COMMENCEMENT OF THE IMPLEMENTATION OF THE ENERGY SECTOR LEVIES (AMENDMENT) ACT, 2025 (ACT 1141)

Reference is made to our previous communication dated 13th June 2025, which announced the postponement of the implementation of the Energy Sector Levies (Amendment) Act, 2025 (Act 1141). This decision was taken in consultation with the Ministry of Finance and the Ministry of Energy to allow for a comprehensive monitoring of global market conditions and to safeguard recent gains in domestic pump prices.

We are pleased to inform you that, following a thorough review of prevailing market indicators and in line with the government's commitment to ensuring stable economic conditions, the implementation of the Energy Sector Levies (Amendment) Act, 2025 (Act 1141), will now commence, effective 16th July 2025.

As previously communicated in TIO No. 2025/004 dated 9th June 2025, Act 114 introduced an amendment to the following levies:
